Time of presentation for treatment and profile of deformities among leprosy patients in South Eastern Nigeria

Summary

A 10 year review of leprosy patients seen at Leprosy Hospital Ekpene Obom in South Eastern Nigeria (1988 - 1997) was carried out to evaluate the effect of early identification and treatment of leprosy patients in the limitation of deformities among them. A total of 2,597 patients comprising 1,714 (66%) males and 883 (34.0%) females formed subjects for the study. Of these 288(11.1%) were aged 15 and below while 2,309 (88.9) were above 15 years. Their case records were thoroughly reviewed noting the duration of disease before presentation, type and location of deformity as well as the type of leprosy.

Though there was a steady decline in the total number of leprosy patients seen over the study period as well as a decrease in the mean duration of illness before presentation, approximately 19% of patients still had deformities at presentation, a figure much lower than those reported by other workers. Analysis of the pattern of deformities shows that most patients 71.2% presented with affectation of the upper and lower limbs with consequent functional disability.

We conclude that early treatment is an effective means of reducing the prevalence of deformity and thus disability from leprosy. More effective implementation of health education and treatment programmes initiated by the W.H.O should further reduce the scourge of leprosy in our community.

Résumé

Une revue biguinquenale sur les lèpreux a l' Hospital d' Ekpene Obom dans le sud-Est du Nigéria (1988-1997) avait èté entreprine. Le but était d'évaluer l'effect d'une identification au stade précaire de la maladie et un'traitement de limiter les déformités entre ces malades. L'étude a été portèc sur totai de 2,597 malades comprenant 1,714 (66%) males et 883 (34.0%) femelles. Leurs dossiers ont été profondament étudiès nontant la

durée de la maladie avant la présentation, la qualité et la location de la déformité autant que le genre de lépre.

Bien qu'il a été noté un dédin sur le nombre total des lépreux vus durant cette periode autant qu'une baisse sure la durée moyenne de la maladie, approximativement 19% des malades ont eu des déformités durant la présentation, un pourcentage bien bas que celui érais par d'auten cherchewn.

L'analyse de genre de déformités a montré qu'un grand nomre de patients (71.2%) s'était présenté avec des affectations au niveau des membres superieurs et inférieurs avec des désabilitiés fontionelles.

Nous concluons done, que le traitement au stade précaire est un moyen effectif de réduire la prévalence des déformités et par conséquent la désabilité de la lépre. L'implementation effective de l'education du la santé et le programmes de traitement initié par l'O.M.S. doivent réduire les scourges de la lépre dans notre communité.

Introduction

Leprosy is a chronic disease that results in various types of deformities and visual impairment. These individuals form a severely disadvantaged group because of these disabilities due to the disease, its social stigma and the difficulty in receiving appropriate treatment.

It is estimated that there are 10–12 million cases of leprosy in the world, out of which only about 5 million are registered for treatment. Furthermore, approximately one third of all leprosy patient are believed to suffer from disability of all grades as a result of deformities. In Nigeria, the Federal Ministry of Health estimates that about 50,000 leprosy patients suffer from severe disability as a result of the disease condition. Thus, in highly endemic areas, leprosy is often the most important disabling disease of the adult after tuberculosis.

Recently, there has been a renewed global initiative by the World Health Organisation (WHO) and other related agencies aimed at controlling the high incidence of leprosy. These control programmes involve health education, early identification of patient and use of multi drug therapy introduced in 1982 for the treatment of affected patients. The introduction of effective chemo-

therapy in national leprosy control programme through multi drug therapy has brought increased attention to the problem of disabilitiies.

The prevention of nerve damage is the simple most important aspect of leprosy management that is often neglected in our hospitals⁵. Similarly, early presentation of patients for treatment in leprosy hospital is rarely achieved in these hospitals because of social and cultural barriers.

Deformities not surprisingly is a function of the disease duration and hence the need for early identification of affected patients. The duration of disease at diagnosis may vary according to health service coverage, the level of awareness of the disease and social stigma.

The aims and objectives of this study is therefore to access the impact of early identification and treatment of leprosy patients with a view of limiting the prevalence of deformities among patients with leprosy. This will invariably evaluate the success and the extent of effectiveness of the new World Health Organisation global initiative on the control of leprosy. It will also help proffer suggestions on the successful implementation of this laudable scheme of the World Health Organisation.

Material and Method

This study was carried out in a leprosy hospital located in Ekpene Obom, Akwa Ibom State of Nigeria. The hospital serves both as a primary treatment centre as well as a referral centre for management of leprosy to five states in the South East of Nigeria. The field staff also carry out contact tracing to these catchment areas. The pool of patients is thus near representative of leprosy cases seen during the study period. The study involved a 10 year study review of the management of leprosy patient at this hospital from 1988 to 1997 aimed at evaluating the effect of early identification and appropriate treatment of leprosy patient in the limitation of deformities among these patients.


A total of 2,597 patients consisting 1,714 (66%) males and 883 (34%) females were subjects for the study. This figure was the total number of patients who presented in the hospital for treatment during the study period and excluded those that defaulted. They were broadly divided into two age groups, patients 15 years of age and below and those above 15 years.

A thorough analyses of each patients record was carried out. Information extracted included the type of leprosy based on the Ridley Jopling classification⁶, duration of illness before presentation for treatment, age at onset of illness, and pattern of deformity. These were carefully recorded in an information sheet prepared for each patient. All data collected were analysed using EPI Infor Version 5 computer software.

Results

The disease classification and the age distribution of the 2,597 patient under survey on yearly basis are shown in fig. 1a and fig 1b. A total of 288 (11%) patient were 15 years of age and below, while 2,309 (89%) patient were above 15 years.

The legend also shows that a total of 359 patients (13.6%) had Tuberculoid Leprosy, 258(9%) males and 101(4.6%) females. Similarly, 2240 (86%) had Lepromatous leprosy consisting of 1,458 (56%) males and 782 (30%) female. However, there were no borderline types of leprosy identified during the survey.

Figure 1a Disease classification of patients aged 15 and below




Figure 1b Disease classification of patients aged above 15




Figure 2 Yearly distribution and number of deformities of patients.




Figure 3 Mean duration of untreated disease before presentation

Figure 2 shows the yearly distribution of patients and number of patients presenting with deformities, while figure 3 is mean duration of illness before presentation for treatment. The number of patients presenting yearly showed progressive decline as well as the mean duration of illness before presentation. The pattern of de-

mar ulcers. However less than 1% of the patient had deformities of the eye such as lagopthalmos, corneal ulceration and cataract while 3.6% had ear and nose ulcerations. Plantar and palmar insensitivities accounted for 7.8% and 6.6% respectively and these are prerequisite for actual deformity.

formities and number of patients involved yearly is illustrated in Table I. A total of 373 (14.3%) males and 160 (6%) females had deformities of various parts of the body. The limbs were most affected, the lower more than the upper.

Table II shows the description of various deformities of the patients. Most patients had multiple deformities especially those with long standing disease condition. 6.4% of the patient had claw toes while 5.2% had mobile claw hands, 4.9% plantar ulcers and 4.5% pal-

Discussion

This study has shown that leprosy is still prevalent in Nigeria. The prevalence rate of Africa has been put at 10 per 1,000 with Central African having the highest prevalence of the disease. It is estimated that approximately 25% of the leprosy patients develop various forms of deformities. However, the degree of deformity is dependent on the duration of the disease and time of presentation for treatment. Our study has shown that 19–23% of the patients reviewed during the study period

had deformities. The lower figure may be attributable to earlier presentation of patients for treatment as demonstrated in this study. Iyere⁸ working in Northern Nigeria however report that 3.8% of patients in his series presented with deformities. A greater percentage (71%) of the deformities in our series were in the extremities and corroborates findings by other workers.^{8,9}

The study also showed that the frequency and degree of deformity were less, the shorter the mean duration of untreated disease. This is similar to findings from other studies which concluded that the incidence of deformities increased among a patient population and also in the number per patient the longer the disease remains untreated. 10-11 It was also noted that patients were presenting earlier for treatment as the year progressed and there was thus a reduction in the frequency of deformities at presentation over the 10 year study period. This could be attributable to the increase awareness through health education of the need to report early for diagnosis and treatment. This has also manifested in the steady decline in the number of new cases that presented during the period. Therefore the efficacy of the mutidrug

therapy introduced by WHO in 1982 is not in doubt. The renewed effort by the WHO in control of leprosy may have begun to produce the desired impact of reducing the prevalence of the disease and subsequent deformity as well as limiting disability.

Recommendation drawn up by the International Federation of Antileprosy Association (ILEP) advocates a programme that gives high priority to the prevention of disability and education of patients in self care¹². This involves patient learning to avoid wounds, skin cracks and joint stiffness, as well as knowing how to care for wounds.

In conclusion, the practice of early identification of leprosy patients and subsequent treatment should be encouraged through enlightenment of target communities. This can be done by use of health officers, the mass media and non governmental organisations.
